

ORDINANCE NO. 81-10

AN ORDINANCE AMENDING ORDINANCE NO. 659, WHICH IMPOSES A LICENSE, TAX OR FEE UPON CERTAIN BUSINESSES, OCCUPATIONS, TRADES AND PROFESSIONS CARRIED ON, CONDUCTED OR HELD WITHIN THE LIMITS OF THE CITY OF SOMERSET, KENTUCKY.

BE IT ORDAINED BY THE CITY COUNCIL IN AND FOR THE CITY OF SOMERSET, KENTUCKY:

That Ordinance No. 659 is amended as follows:
