**RESOLUTION NO. 14-05**

**A RESOLUTION OF THE CITY COUNCIL OF SOMERSET, KENTUCKY, TO AUTHORIZE THE MAYOR TO ENTER INTO AGREEMENTS AND MAKE PURCHASES IN PREPARATION FOR THE SALE OF GASOLINE FROM THE CITY'S BULK GASOLINE PLANT**

WHEREAS, the City of Somerset owns and operates a bulk gasoline plant which was purchased to provide gasoline to the fleet of the City's vehicles that are operated by the City's employees, agents and officials;

WHEREAS, the City of Somerset has demonstrated in its operation of the bulk plant that the City is capable and competent in providing gasoline for the operation of the City's fleet and also in providing natural gas for the operation of vehicles in the fleet and also for vehicles of the public that are equipped to operate using natural gas;


WHEREAS, the City of Somerset has now entered into agreements for the sale of gasoline to other governmental entities, including the Somerset School System, and has further demonstrated that the City is capable and competent in the delivery of gasoline to the vehicles of these other governmental entities;


WHEREAS, the City of Somerset finds it in the interest of the City and of the public to enhance the bulk gasoline plant owned by the City to prepare the plant for the sale of gasoline to the public;

NOW, THEREFORE, be it Resolved by the Common City Council of the City of Somerset, as follows:

The Mayor of the City of Somerset is hereby authorized consistent with the Model Procurement Code to sign and enter into agreements for and to make purchases of the equipment necessary to allow the City to provide gasoline for sale to the public from the City's gasoline bulk plant.
