THIS ORDINANCE NUMBER 14-07 FIXING THE TAX LEVY, AD VALOREM, FRANCHISE TAX, AND TAX FOR THE CITY OF SOMERSET, KENTUCKY, FOR THE FISCAL YEAR BEGINNING JULY 1, 2014 AND ENDING JUNE 30, 2015 PROVIDING PENALTY AND INTEREST FOR NON-PAYMENT.

AN ORDINANCE IMPOSING A BANK FRANCHISE AND LOCAL DEPOSIT TAX: SETTING FORTH TIME TABLES FOR THE COLLECTION OF SUCH TAX FOR THE YEAR 2014 AND ALL SUBSEQUENT YEARS: AND SETTING FORTH ENFORCEMENT PROCEDURES, INCLUDING PENALTIES FOR THE COLLECTION OF DELINQUENT TAXES.

ORDINANCE OF THE CITY OF SOMERSET, KENTUCKY AUTHORIZING AND PROVIDING FOR THE ISSUANCE OF \$9,350,000 PRINCIPAL AMOUNT OF CITY OF SOMERSET GENERAL OBLIGATION BONDS (ENERGY CENTER PROJECT), SERIES 2015, CONSISTING OF \$8,500,000 OF SERIES A BONDS AND \$950,000 OF SERIES B BONDS, FOR THE PURPOSE OF FINANCING THE COST (NOT OTHERWISE PROVIDED)OF THE CONSTRUCTION OF AN ENERGY CENTER FOR SAID CITY; SETTING FORTH TERMS AND CONDITIONS UPON WHICH SAID BONDS MAY BE ISSUED AND OUTSTANDING; PROVIDING FOR THE COLLECTION, SEGREGATION AND DISTRIBUTION OF THE TAX REVENUES OF SAID CITY; AND PROVIDING FOR AN ADVERTISED, PUBLIC COMPETITIVE SALE OF SAID BONDS.

Mr. Rutherford move to approve the reappointment of Wanda Mabry to the Somerset Ethics Board. Term expiring 07/18. Mr. New seconded the motion.
