

# CITY OF SOMERSET - PULASKI COUNTY

## Amendment to Inter-Local Cooperation Agreement:

### Occupational License Fee Agreement

**WHEREAS**, the City of Somerset and Pulaski County entered into an Inter-Local Cooperation Agreement pursuant to KRS Chapter 65, otherwise known as the "Inter-Local Cooperation Act", on the 9<sup>th</sup> day of May, 2016, in regards to revenue sharing of the local occupational license fee, said Agreement attached hereto and incorporated in full herein by reference as an Exhibit to this Amendment; and

**WHEREAS**, the City and the County now wish to amend said Inter-Local Agreement to extend the original term of said Agreement for an additional 5 (five) years, resulting in an initial Agreement term of 10 (ten) years;


**NOW THEREFORE**, the City of Somerset and the County of Pulaski do hereby wish to Amend the parties' Inter-Local Occupational License Fee Agreement, pursuant to section IX. of the original Agreement. The City and County, as evidenced by the signatures of the Executive Authority of each Agency as required by all applicable law, and with documentation of legislative action of the governing bodies attached hereto and incorporated in full by reference, do hereby amend Paragraph VIII as set forth below:


#### **VIII. Term of Agreement**

This Inter-Local Agreement shall become effective July 1, 2016 and shall remain in full force and effect until ~~June 30, 2021~~ June 30, 2026, unless terminated pursuant to Section IX herein.

No other terms or conditions shall be effected by this Amendment, and this Amendment shall become operative and have full force and effect upon the date of the last signature of the parties/agencies obtained below, following approval by the legislative bodies of each agency, the signature of the Kentucky Department of Local Government if required, the filing of the Agreement with the Kentucky Secretary of State, Frankfort, Kentucky, and finally with the filing of the signed and approved Agreement with the Pulaski County Clerk's Office, Somerset, Kentucky.


