

## MINUTES OF MEETING HELD JULY 13, 2015

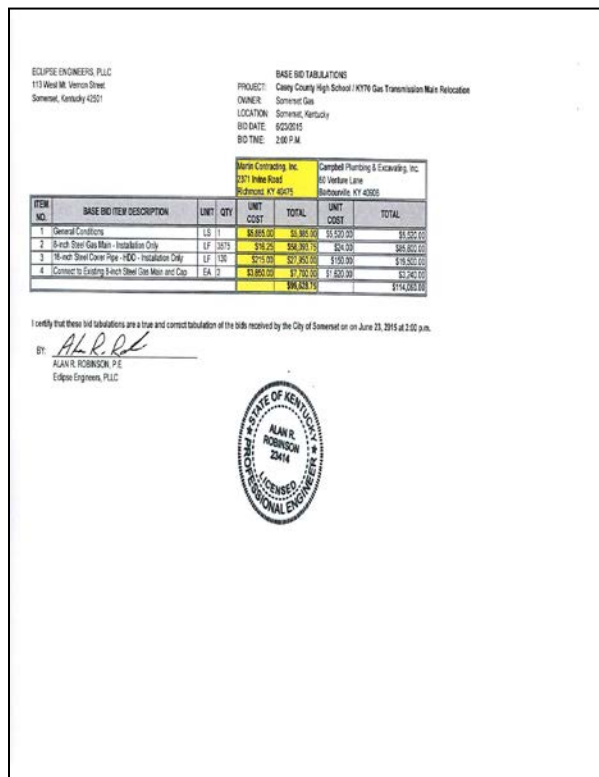
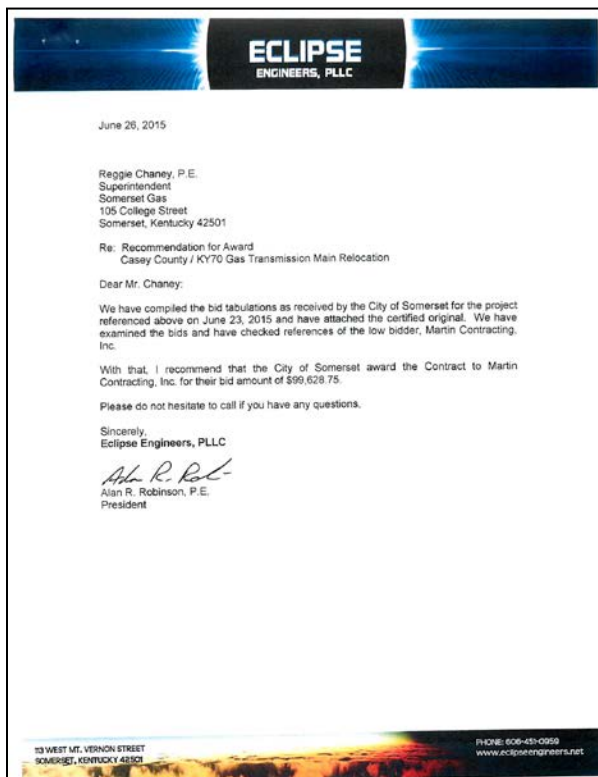
The Common Council of the City of Somerset, Kentucky met in a regular meeting on Monday July 13, 2015, at 7:00 p.m. with the following present: Mayor Pro Tem Mike New. Council Members; Donna Hunley, John Minton, Jim Mitchell, Jerry Burnett, David Burdine, Linda Stringer, Jerry Wheeldon, Jerry Eastham, Mike New, and Pat Bourne. City Attorney Carrie Weise, and City Clerk Nick Bradley. Absent: Mayor Eddie Girdler. Council Members; Tom Eastham, and Jerry Girdler.

Mr. Wheeldon moved to approve the minutes of the regular meeting held on June 22, 2015 along with reports as mailed. Mr. J. Eastham seconded the motion. Mr. Burnett then made a motion to amend the original motion to exclude the FY 2015/2016 Budget Ordinance from the minutes until Charlie Cole comes to explain exhibit "C". Mr. Mr. Bourne seconded the motion. Upon roll call the following Council Members voted "Aye": Mrs. Hunley, Mr. Minton, Mr. Mitchell, Mr. Burnett, Mr. Burdine, Mrs. Stringer, Mr. Wheeldon, Mr. J. Eastham, and Mr. New. Choosing to "Pass: Mr. Bourne. Motion Passed.
