



## MINUTES OF MEETING HELD MAY 23, 2016

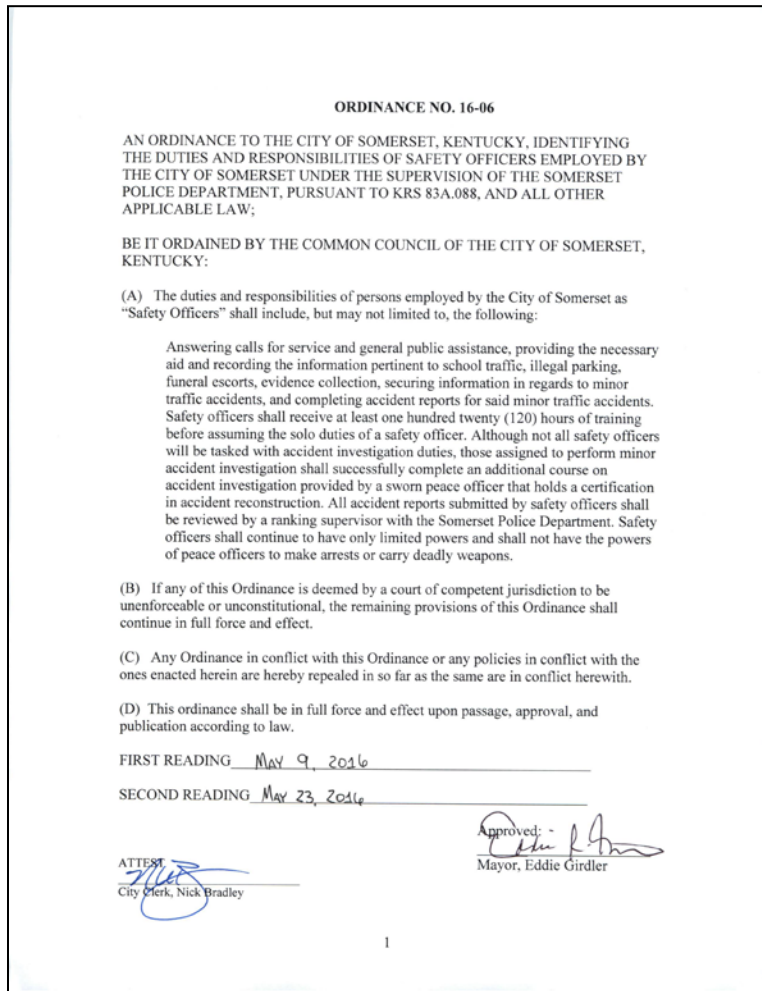

Second reading was given the following Ordinance No 16-05:

<p>ORDINANCE NO. 16-05</p> <p>AN ORDINANCE DESIGNATING CRANE STREET, SPECIFICALLY FROM GOOCH STREET TO ECKSTEIN STREET, AS A ONE-WAY STREET IN THE CITY OF SOMERSET, KENTUCKY.</p> <p>BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SOMERSET, KENTUCKY.</p> <ol style="list-style-type: none"><li>1. That the street described above shall now be a one-way street in the City of Somerset, Kentucky, which shall begin at Gooch Street and shall end at Eckstein Street, running in an East to West direction.</li><li>2. All ordinances or partial ordinances in conflict herewith are hereby repealed.</li><li>3.
